Treasurer's Report

I want to thank all of the homeowners who have helped to make my job as the Treasurer for the past year successful and enjoyable.

In this newsletter I have included the First Reminder to pay the \$100 annual dues for the calendar year 2007, which will be due to the HFCA beginning January 1, 2007. Dues received after March 31, 2007 will be subject to an additional \$25 late fee. Please note that this late fee is mandated by the Hickory Farms Community Association BY-Laws and as such cannot be waived by the board. In previous years when late payers have requested the Board to waive this fee, the request has been denied.

For those who are new homeowners, this is your reminder to pay the annual dues. We do not mail any bills to homeowners.

If You Plan To Sell Your Home

If you are planning to sell your home in the upcoming year, keep in mind that you will need to obtain a VPOAA package from the HFCA. The package is required by law.

The following are the steps for obtaining a VPOAA package:

- Contact the Treasurer. Let him know when the package is needed and where it should be sent.
- Draft a check for \$50, payable to the HFCA. The check can be mailed to HFCA, P.O. Box 2239, Fairfax, VA 22031-2239; or make other arrangements with the Treasurer as necessary.

Please allow 7-10 days from receipt of the check by the Treasurer to the date the VPOAA package can be released, as we must allow time for the check to clear. Should time be critical, cash payments can be accepted and a written receipt will be provided.

GroundsRich Dudley

The state of our common areas remains good. Recent activities to improve our grounds have included:

- Keith Ferguson organized a work session to replace the bridges crossing Rabbit Run after they were washed away in summer floods. Thanks to Keith and crew for their effort!
- The growing pot hole in the asphalt walkway in the Lower Common Area was repaired with a temporary patch. We will look at longer-term solutions to deal with similar asphalt problems and see whether it is prudent to engage a contractor in making more substantial repairs.
- We made some progress in removing vines from trees in one part of the Upper Common Area. The affected trees have been on the decline for several years so the improvement should make a difference to the longevity of the trees. Lots more work remains but we're making progress.

Our 17 acres of common areas are one of the greatest assets of the neighborhood. Please help us maintain them by volunteering an hour of your time to help us with projects. Contact Rich Dudley (dudley_richard@bah.com or at 703-503-2060) if you would like to volunteer for a project. A few of our more pressing needs include:

- We need volunteers to help cut back brush and low-hanging trees from the Lower Common Area's sledding hill before we have our first snow.
- The Upper Common Area needs a thorough trash pick up now that leaves have fallen from trees and bushes to reveal trash that had been previously hidden.

On a closing note, please do not place your yard debris and leaves in the Common Areas. In addition to being against our neighborhood association rules, such piles of debris can be unsightly and take a long time to decompose.

Driving on Common Grounds – Don't

The common areas (the woods, walking paths, and upper and lower grounds) are for the enjoyment of all Hickory Farms homeowners and their guests. This does NOT include, however, the use of motorized vehicles like mopeds and motor scooters. Our insurance doesn't cover them and they tear up the grounds and grass. Our rules don't allow them. So, if you ride one of these vehicles, please find somewhere else where it is legal to ride them.

Do You Need Tree Work Done?

Note: This group buy will **not** happen unless someone volunteers to coordinate.

Our attempt to get discounted tree work done in February fell flat with the snowstorm that downed a lot of trees in the area. Tree companies had plenty of full price work and weren't interested in cutting us a deal. Well, some folks still need to have tree work done, myself included. However, we need a coordinator who will 1) get bids from 2-3 contractors to compare prices (we already have a list of names, including the 2005 contractors), 2) select a contractor, 3) contact HF homeowners to find out who's interested, and 4) pass that info on to the selected contractor. **We can't move forward without a coordinator.** If you could put in just a few hours on an endeavor that could save you and your neighbors some money, please contact kirk randall@hotmail.com or call 703-425-0210. Work is usually done in February or March – the (usual) slow season for tree contractors – so contractor selection and contacting homeowners should be done in January.

Disposing of Your Leaves and Yard Debris

Fall is leaf raking time. If we lived just a few blocks north in Fairfax City, we could just rake our leaves into the street and city workers would vacuum them up. But, alas, we live in Fairfax County, so *please don't rake your leaves into the street!* Here's the skinny on disposing of your leaves (and other yard debris) in our community.

 Under Fairfax County ordinance, the trash collector is supposed to remove up to six bags of leaves on a yard debris pickup day. If you put out more than six, the extras may or may not be taken. To its credit, however, AAA almost always picks up everything you leave out.

- If the trash collector doesn't take all of your leaves on your yard debris pickup day, please don't just leave them in the street or the parkway (that strip of grass between the street and sidewalk) for the next week's pickup. The bags kill the grass if left on the parkway, or block the mailman if left near the mailbox.
- Please don't put your trash, recycling, or yard debris out several days before
 pickup; it detracts from the nice appearance of our neighborhood. Under our
 Rules and Regulations, refuse should be put out on the collection day or the prior
 evening.
- Speaking of pickups, trash collections may not occur before 6 AM. If you're awakened by the sound of trash trucks before 6 AM, please first call the trash company to report the problem. If they don't comply with your request, you may report them to the Fairfax County Zoning Enforcement office at 703-324-1300 between 8 AM and 4:30 PM.
- Under Fairfax County Ordinance, you should not use black plastic bags for yard debris such as leaves. You are supposed to use clear plastic bags. The trash collector may refuse to take black bags because its workers can't tell whether you put garbage or yard debris such as leaves in the bags.
- Place twigs and branches in a trash can or cut them to approximately four feet in length and bundle them using twine. The trash collectors may refuse to take them if they are not bundled.
- Please do not dump leaves, tree branches, and grass clippings in nearby common areas or woods. Not only is it against our <u>Rules and Regulations</u>, but it creates a tremendous burden on the ecosystem. Wooded areas are ecologically balanced; they can decompose just about as much organic matter as the trees themselves produce. When you add your leaves, branches, or grass clippings, it overloads the ecosystem and they don't decompose. The result is a wooded area that looks and smells like a dump. Help keep our common grounds and woods beautiful by not dumping leaves, tree branches, and grass clippings there. (From Hickory Farms Web Site)

Be Considerate of Your Mailman

The mailman can deliver our mail more quickly if he/she doesn't have to leave the truck to walk around trash cans. Help the mailman by placing your trash cans at least 12 feet away from your mailbox.

Hearing Impaired Smoke Alarm Program

The Fairfax County Fire and Rescue Department offers a program to provide fire safety for the hearing impaired in our community. The Visual Smoke Alarm Loan Program offers a special device to alarm deaf/hard of hearing occupants when smoke or fire is detected. The alarm will produce an increased audible alert and emit a strobe light when activated.

Residents and visitors to Fairfax County can obtain one of these "loaner-for-life" alarms by contacting the Public Information and Life Safety Education Section at 703-246-3801. You may retain the alarm for as long as you reside in Fairfax County.
