President's Message

While conducting my recent Neighborhood Watch tour, I was pleased to see that people have begun putting up their holiday decorations. I hope I can get mine up before the snow flies!

Speaking of snow, the Virginia Department of Transportation (VDOT) has the responsibility of snow removal and anti-icing treatment for our roads. VDOT's priority is to clear interstates and high volume roads first. Once the most heavily traveled roads and emergency routes are cleared, snow crews move to less-traveled roads and subdivisions. A VDOT spokesman advised me that VDOT won't clear residential areas unless at least two inches of snow have fallen, or if a hazardous condition exists. If at any time you are aware of a hazardous road condition, please call VDOT at 703-383-8368.

When snow is anticipated, park your cars in driveways, not in the street. This makes it easier for the plows to clear the roads. When clearing your driveway, pile the snow to the right (when facing the road) so that when the plow comes, it won't push your own snow back in your driveway. Please clear the sidewalks in front of your property. And while you're clearing your driveway or sidewalks, please don't throw the snow out into the streets; the whole point of plowing is to get the snow off the streets!

This Month's Home Maintenance Checklist

Heating & Cooling Duct Cleaning – Have a professional vacuum the accumulated dust out of the ductwork every ten years or so – if needed.

Gutter Cleaning – Clean out your gutters. Overflowing gutters lead to ground erosion and wet basements. If you are surrounded by trees, you may have to do this both Spring and Fall.

Furnace Humidifier Setup – If you have a furnace humidifier, make sure it is plugged in and set properly. Turn on the water supply valve. If you did not do so in the spring, scrape off mineral buildup in the water pan and replace the filter – if needed. Work the float arm back and forth to dislodge mineral deposits.

News for Our Dog Walkers

If you have been tossing your dog's droppings down storm drains ("sewers"), then please read this. Our neighbors in nearby Aspen Grove townhouses on Roberts Road (about a block south of the swimming pool) have alerted us that dog poop is appearing in their neighborhood. Our storm sewers run under Roberts Road and then spill onto Aspen Grove's common areas. Unfortunately, it's not just rainwater that gets dumped on Aspen Grove; it's also plastic bags filled with dog droppings. So, rather than tossing your bags into the nearest storm sewer once you've cleaned up after your dog, please use a trash can. Our Aspen Grove neighbors thank you.

Treasurer's Report

Seasons Greetings! I want to thank all of the homeowners who helped make my job as the Treasurer for the past year successful and enjoyable.

In this newsletter, you will find the first of four reminders to pay the \$110 2008 annual dues.

Your dues payment envelope must be postmarked by March 31, 2008. Payments postmarked after that date are late and will incur a *mandatory* \$25.00 penalty. The Association's By-Laws stipulate that late fees cannot be waived.

You will *not* receive a mailed bill. Your only notice is in the newsletter.

A reminder that, under Virginia law, you must obtain a Hickory Farms VPOAA package *before* you can sell your home. To obtain such a package,

- 1. Contact the Treasurer. Let him know when the package is needed and where it should be sent.
- 2. Send a \$50 check to HFCA, P.O. Box 2239, Fairfax, VA 22031-2239.
- 3. Allow 7-10 days for your check to clear before the package may be released. In an emergency, you may arrange with the Treasurer to pay with cash.

Sidewalk & Driveway Maintenance Tip

Never use salt on the driveway or sidewalk to melt ice or snow. Salt eats away concrete in the blink of an eye. Although using salt to melt snow and ice is convenient in the short run, you'll pay for it when you have spend \$ thousands for a new driveway. If you must use an ice or snow melting chemical, make sure the package says it will not damage concrete. (12)

Disposing of Your Xmas Tree

AAA schedules special pickups for your Christmas tree on the first and second Wednesdays in January – January 2 and 9 this year. Beginning with the third week of January, put your tree out with your regular trash. AAA will not pick up your tree if it is in a plastic bag. (1-12)

If a check is returned for insufficient funds, the homeowner must reimburse any expenses incurred by the HFCA.

The HFCA is committed to maintaining and improving the equality of life in Hickory Farms, to maintaining our property values, and to resolving issues of concern to our neighbors. Assessments (and late fees) are collected in accordance with the Association's By-laws to cover HFCA, which are outlined and approved by the homeowners at each Annual Meeting.

If you are not a property owner, you are not responsible for paying the assessment; please forward this notice to the property owner.
