Revised Rules and Regulations to Be Presented at Annual Meeting

At the October 2012 Annual Meeting, the Board of Directors approved and proposed revisions to the HFCA Rules and Regulations. Following debate, the proposed changes were directed to a group of volunteers for additional analysis, review, and possible revision. The Revised Rules and Regulations Subcommittee reviewed the existing HFCA founding documents and revised the Rules and Regulations to more closely align the two documents. Fairfax County records were even checked to confirm that we were using the correct versions of our founding documents.

As of October 9, no Homeowner comments have been submitted. That evening, the Board of Directors approved the proposed Revised Rules and Regulations. They will then be presented to the membership at the Annual Meeting. This Month's Home Maintenance Checklist

Dehumidifier Shutdown – Clean out the dehumidifier bucket and vacuum the coils.. **Test Water Overflow Alarms** – Avoid floods by placing water overflow alarms next to your washing machine, hot water heater, etc.

Test Smoke Alarms & Carbon Monoxide Detectors – We recommend that you replace smoke detector batteries and don't wait for them to die. Press test buttons on carbon monoxide detectors. Open each unit and vacuum dust that could interfere with operation. Carbon monoxide detector batteries are usually not replaceable by the user; replace the unit when indicated on the unit's instructions. Check the date on each alarm. Most older smoke and carbon monoxide alarms should be replaced after seven years. Replace them with alarms that are guaranteed for ten years.

Water Heater Flushing – Drain the hot water heater to remove sediment that makes it run inefficiently. If gas operated: Turn the gas valve to the "pilot" setting. If electric: Turn off the circuit breaker. Shut off the cold water supply valve. Connect a hose from the water heater drain valve to the nearby floor drain or outdoors. Open a nearby hot water faucet to help the water drain freely. Open the water heater drain valve. When the water starts running cold, close the heater drain valve and remove the hose. Open the cold water supply valve. When water flows freely from the open sink faucet, turn off the faucet. Turn the gas control back to the "on" setting, or the electric circuit breaker back on.

The Birds of Hickory Farms—Fall 2013 Bob Cosgriff

The results are in and 2013 can claim to be the best year ever for the bluebird trail. We had 10 boxes (eight donated by Girl Scout Troop 2046 and two older HFCA boxes). Of these, three boxes were actually used by bluebirds and three by tree swallows. With two boxes for each species having two successful broods each, we successfully fledged 22 bluebirds and 16 tree swallows. Two boxes were used by house wrens, with eight birds fledged. One box was installed later in the season by Rabbit Run on Cotton Farm Road and had some 'lookers' but no takers. One box in the upper common grounds was 'sacrificed' to house sparrows to keep them from driving out the more desirable native bluebirds and tree swallows in nearby boxes. We had one 'paired' set of boxes in the upper common grounds, visible from Farm House Lane, which attracted bluebirds to one and tree swallows to the other at the same time. These birds will tolerate each other in close proximity, but not birds of their same species. The advantage is that tree swallows are generally able to drive off House Sparrows which will evict bluebirds. I plan to use another paired set of boxes in the lower common grounds next year to see if we get the same result.

We also added another species, Louisiana Waterthrush, to our neighborhood list on July 6th, bringing our total to 110 species seen in, over, or from Hickory Farms at least once since 1979. Despite its name, this bird is actually a large warbler that typically nests in creek banks. Rabbit Run provides suitable habitat, but until now, this species has not been seen or heard here. The springtime is the best time to locate the waterthrush because it is more vocal. I saw this bird walking along the sand and rocks in the creek south of the culvert under Cotton Farm Road. I suspect this bird was beginning to move south, since this species is one of the earliest fall migrants, leaving its breeding grounds in July for its wintering territory in Cuba and farther south in the Caribbean and South America.

Speaking of the fall migration, it is beginning now, especially along the coast, with the shorebirds and waders. But that's a topic for another time. Until then, enjoy the backyard birds of Hickory Farms, especially our beautiful bluebirds. Some of them will probably stay around during the winter, where they can be attracted to feeders by suet and mealworms.
