Woodson Band's Annual Tag Day – September 8

Please Clean Up After Your Pets

There are far too many instances of people not cleaning up after their dogs. Several folks are not cleaning up after their dogs poop in a neighbor's yard. We also have neighbors who are throwing bags of dog poop into the storm drains or into common area woods. Fairfax County Code Section 41.1-2-6 states that "the owner or custodian of any dog shall be responsible for the removal of excreta deposited by such dog on the property of another, including public places." Cleaning up after your dog is not only the law but is a common courtesy that should be expected within our community. Please do the right thing and clean up after your pet and dispose of it properly with your trash.

Smoke Alarms Should be Replaced At Least Every Ten Years

There was a recent conversation on the Hickory Farms e-mail list about fixing smoke detectors that were installed when the house was constructed – at least 26 years ago. If you

think you may have 25+ year old smoke detectors, they are long overdue for replacement. The US Fire Administration / Department of Homeland Security recommends replacing smoke detectors every 8-10 years, whether they appear broken or not. Trash Company Alternatives

A few HF residents have voiced frustration with AAA Disposal Services and asked me to research alternatives. AAA's competitors are family owned and operated, and all offer twice weekly pickups of trash, recycling, and yard debris. Only AAA and New Vision offer customers the large 96 gallon tote bins and recycling containers; the other companies require you to use your own trash cans or trash bags. (This may be a consideration if you have lots of trash; if you don't, a tote bin may not be a factor and you don't have to lug the bins and containers back from the street after trash is collected.) New Vision will pick up your trash/recycling from the street or from in front of your garage/carport – the postman might also like that if he doesn't have to dodge your trash can to deliver your mail! The Birds of Hickory Farms

This summer was the best one yet for Hickory Farms in terms of nesting bluebirds. We had a total of three nests in the lower common grounds, with two being successful, meaning the eggs hatched and the baby blue birds fledged. Additionally, a pair of bluebirds successfully brought off a brood in a box in the corner of the Dudley's backyard (on the upper common ground). The first nests (one in LCG and one at Dudleys) were underway by 8 April, with eggs appearing in early May. The entire process of incubating, rearing and fledging was over by early June.

The pair at the Dudleys attempted to nest again, but was not able to drive off the more aggressive House ("English") Sparrows. At the same time, a second nest was started in the successful box in the lower common grounds, but ultimately, the nest was hit by predators. That appeared to be it for the season, but the birds moved to another box, and between early July and 7 August, laid four eggs and fledged at least three young birds successfully. This was the second "three-brood" year, the other being 2002. Hickory Farms is lucky to have these beautiful birds select our suburban setting for their home.

We had an additional success: Tree Swallows took a box in the upper common ground and laid four eggs. Unfortunately, English Sparrows evicted them in early June, just as the eggs were ready to hatch. This is only the second Tree Swallow nest in Hickory Farms, the other being in 2001, when these beautiful and beneficial birds laid two eggs in a box in the lower common grounds. Unfortunately, they abandoned that nest for reasons unknown and the eggs never hatched. We will have to hope that next year, they will finally be successful.

Other colorful birds seen and heard in Hickory Farms in 2007 include Yellow Warbler, American Redstart (another warbler), Eastern Meadowlark (first-time sighting here), Purple Finch (first in many years), Blue-gray Gnatcatcher, Rose-breasted Grosbeak, Wood Thrush, Baltimore Oriole, White-eyed Vireo, Fox Sparrow, and Brown Thrasher. Hickory Farms boasts a good assortment of woodpeckers, with plenty of Downy, Hairy, Flicker, and Redbellied, and an occasional Yellow-bellied Sapsucker. Additionally, the impressive Pileated Woodpecker was observed on numerous occasions throughout Hickory Farms in 2007. As for larger birds, the Great Horned Owl returned to the upper common ground in the midwinter period. Red-tail and Red-Shoulder Hawks perched in our trees and soared overhead. Both Sharp-shinned and Cooper's Hawks made their appearance. Great Blue Heron, Turkey Vulture and Osprey were seen in the skies above Hickory Farms.

As the summer draws to an end and autumn approaches, many birds are preparing to migrate south. While the fall migration is not as dramatic as the spring migration, there will be plenty of chances to see birds stopping by from points north of here or flying over between now and November. However, we are fortunate in that many species maintain a year-round presence. All it takes to attract them to your yard any time of year is birdseed (black oil sunflower, peanuts and suet work best), water and cover. Of course, our beautiful common grounds provide all three of these essential elements, so take advantage of what we have here and "take a walk on the wild side" to see what you can see!

Your Remodeling Project May Require ACC Approval

If you are changing the exterior appearance of your home, you may need Architectural Control Committee approval. Please don't run the risk of holding up the start of your project awaiting ACC approval; submit your proposal to the ACC as early as possible. You *must* have ACC approval before you begin the project. Protect Your Underground Water Pipe

Every few years, we seem to have a rash of water pipe breakages. For some reason, our water pipes (the pipe that runs from the street to your home) seem to be prone to failure. When this pipe breaks, *you* pay to have it fixed, and it will likely cost a *minimum* of \$3,000. Protect yourself with a water line insurance policy *before* the pipe breaks. Dominion Products

(a cousin of the electricity folks) offers water line insurance for only \$3.25-\$5 per month (included with your electricity bills). Call 1-866-545-9810 or visit http://retail.dom.com/products/warranty/va_waterline.jsp
You should consider insurance if your water line is especially long. (9)

Range Hood Cleaning – Clean the greasy kitchen range hood screen

Refrigerator & Freezer Cleaning – Use a vacuum cleaner or special refrigerator brush to clean the refrigerator coils, which are usually under the refrigerator. This is especially important if you have pets. Place a piece of paper between the door and rubber seal of the refrigerator/freezer. If it can be moved while the door is closed, there is a leak and the seal should be replaced, or the latch may need adjustment. Drain and clean the drip pan under the refrigerator. Defrost non-frost free refrigerators & freezers; they use less electricity when the frost buildup is removed.

Siding Cleaning – Pressure wash the vinyl/aluminum siding every 3-5 years. Frequent pressure washing can strip the paint off aluminum siding down to the bare metal, so don't do this too often.

Washing Machine Hose Check – Check water hoses for cracks and replace, if needed. Better yet, replace them with metal reinforced hoses.

Dangerous Roberts Road Intersection

Mike Martin has agreed to answer your questions on this topic at October's homeowners' meeting.

Mike became involved with this project while a Board member a few years ago. He continues to raise safety concerns on our behalf and reports back to the Board and community at large. Please give him a hearty "Thank You" for pressing VDOT and Fairfax County on our behalf.

On July 16, 2007, Mike attended a meeting hosted by County Supervisor Sharon Bulova and State Representative David Bulova regarding the traffic issues surrounding the Roberts Road entrance to the Hickory Farms and Aspen Grove communities. The

Virginia Department of Transportation (VDOT), Fairfax City, and Fairfax County also participated. This is his report.

Motor Vehicles

The major issue discussed was the continuing poor sight lines caused by the various dips and hills along Roberts Road. This is a problem for both residents of the communities, but especially their guests who may not be aware of the poor visibility.

Fairfax County has considered leveling the hills and re-grading the large dips on Roberts Road. However, this idea has several major disadvantages including cost and right of way issues and is NOT going to be implemented.

Some of the ideas discussed included stop signs on Roberts Road where it intersects with Still Meadow Road, and increased traffic signage alerting people to poor visibility. Roberts Road stop signs won't work because cars could slip downhill when the road is icy. VDOT also claims t it has no approved signs that could warn oncoming traffic about the poor visibility danger.

Pedestrian Traffic

At the meeting, I explained that the pedestrian traffic on Roberts Road is VERY dangerous. There is no contiguous sidewalk or system of sidewalks from Fairfax City to Hickory Farms to Braddock Road/George Mason University, and there is no crosswalk from Hickory Farms to the swimming pool without having to walk in the street.

I was informed by VDOT's representatives and a member of Sharon Bulova's staff that the current placement of Roberts Road is outside the boundaries of the right of way from the Catholic Church down to that next street. So, in order to put in a sidewalk, the right of way would have to be bought from those houses along that stretch of roadway. GMU is aware of the problem as well, and has included a sidewalk on its side of the street sometime in the future.

I also noted that there is no crosswalk for HF residents who wish to cross the street to the swimming pool, a dangerous situation for the many families with children.

Outcome

- 1. George Mason University is installing a traffic signal at their entrance on Roberts Road by the Catholic Church. This is purported to address several problems including pedestrians crossing Roberts to go to the church. The traffic engineers were hoping this might also bunch traffic up and allow for safe gaps for residents of our communities to safely turn into or out of the side streets onto Roberts Rd.
- 2. The City and County are going to look into placing a crosswalk across Roberts Road from the Hickory Farms side to the Pool side on the flatter section of Roberts Road towards Fairfax City.

AUGUST UPDATE: On August 2nd, Fairfax City constructed a crosswalk across Roberts Rd.

that is almost directly in front of the swimming pool. I encourage everyone in the community to utilize the new crosswalk as it will allow for safer pedestrian access to the pool. Pedestrians should not cross in front of the Still Meadow entrance as you may not be able to see oncoming traffic. Please make sure your children are aware of the dangers of crossing from the Continuing Education Center parking lot directly onto Still Meadow and the presence of the new crosswalk.

- 3. David Bulova says he will sponsor legislation to transfer maintenance of Roberts Road up to the Aspen Grove community to Fairfax City. This is aimed at cutting the bureaucracy of building the proposed crosswalk, as well as, any future changes (Like the addition of stop signs!)
- 4. Stepped up Police enforcement of the speed limits along Roberts Road.

What we can do now

I urge you to contact Supervisor Sharon Bulova (703-425-9300 http://www.fairfaxcounty.gov/braddock/staff.htm), State Representative David Bulova (703-310-6752 e-mail deldbulova@house.state.va.us), and our other elected officials to stress the need for increased safety measures along Roberts Road. The construction of the crosswalk is a great first step to pedestrian safety. I urge you to speak to the elected representatives about the need for complete sidewalks along Roberts Rd. and for additional traffic safety measures at the Still Meadow entrance.

Open Garages Invite Burglaries

By Virginia Law, the time of day dictates what crime can be charged in regards to the thefts from garages. During the day, if someone enters an open garage and steals items, it is a larceny (petit or grand larceny depending on the value of the items). However, during nighttime hours, if someone enters an open garage of another with the intent to commit a crime, it is a burglary, which is a felony. It is important to remember also, that by leaving your garage open, it gives easier access into your home. Please encourage neighbors and loved ones to keep garage doors closed at all times. It only takes a matter of seconds for someone to enter an open garage and steal items.

Please Keep Your Carport/Parking Area Neat and Tidy

Some of our carports detract from the appearance of the neighborhood. A cluttered carport is as visible to your neighbors as not mowing your lawn. And, items left in your carport are vulnerable to being stolen or damaged by the weather. So, with winter approaching, now is a good time to clean out your carport. Only leave in your carport those things you think you'll actually need. As a general rule of thumb, if you can't park your car in your carport, then you have too much "stuff" there; please consider removing or relocating some of the items. – The

Our Common Grounds

Despite the summer drought, the commons areas look to have fared pretty well. Mother Nature's recent rain has "greened up" much of the grass and we look to be in good shape – at least at the moment. I plan to organize a Fall Clean-Up of the common areas in October. Fall is also a good time to spot trash that's been buried under the summer foliage. I'll need several volunteers pick up trash and cut back limbs and vines that have encroached on our pathways and open spaces. Clean-ups are an excellent opportunity for 7th and 8th graders to earn community service hours.

Homeowners are reminded to keep trees and bushes from overgrowing and encroaching on sidewalks. In my walks through the neighborhood, I've noticed a number of places where trees (particularly Crape Myrtles) and other bushes have obstructed passage on sidewalks so much that one has to walk in the street to get around them. Now is an especially important time to cut back trees and bushes that obstruct the sidewalks because our neighborhood kids are beginning school and need clear pathways to walk to bus stops.

Fall is also a good time to undo damage the summer's drought has done to our lawns. You will have much better luck planting new grass seed in early Fall than waiting until Spring. Lay grass seed in mid-September and you should have a good looking lawn (provided we get more rain) by November. And, grass planted during the Fall will have enough time to grow good roots in preparation for the next growing season. I've learned from experience that grass planted in the Spring frequently dies in the Summer heat.

Parking Your Boat or Trailer in Your Driveway – For Short Term ONLY

Article VII, Number 11 of the Hickory Farms Covenants states:

No boats, trailers, tents or any structure of a portable nature, or portable vehicle other than automobiles shall stay parked forward of any dwelling for a period exceeding seven days.

What does this mean? The term "parked forward of' has the meaning of "forward of the front line of the house," whether in the street, on the lawn or in the driveway. The enumeration of examples is fairly clear, but is not necessarily all inclusive. "Seven days" has the implied meaning that it is a one-time maximum. If it meant such a vehicle, say a trailer or boat, could sit for six days, be moved for one day and then returned, it would defeat the purpose of the rule which is to avoid a storage lot appearance which detracts from the neighborhood and property values. Applying common sense, we must construe "automobile" to include small pickups and small panel trucks, etc. which are used for daily transportation to and from work. Excluded in the meaning would be large commercial vehicles, such as a stake body truck, school bus, recreation vehicle, etc. In addition to detracting from appearance, these also create a safety hazard due their size.
